This Registration Statement as originally filed related to the offering of 12,000,000 shares of PCS Common Stock issuable under the 1988 Employees Stock Purchase Plan. As of April 23, 2004, 11,991,627 of these shares had been issued, leaving 8,373 shares of PCS Common Stock covered by this Registration Statement.

On February 28, 2004, Sprint's board of directors approved the recombination of the PCS Common Stock and the FON Common Stock, effective on April 23, 2004 (the "Conversion Date"). None of the remaining 8,373 shares of PCS Common Stock were issued before the Conversion Date. Following the recombination of the PCS Common Stock and the FON Common Stock, no shares of PCS Common Stock may be issued. Accordingly, the purpose of this Post-Effective Amendment No. 1 is to deregister the remaining 8,373 shares of PCS Common Stock

covered by this Registration Statement.
