## Explanation of Responses:

(1) On 8/7/14, RSU shares were granted, vesting 25% per year over a four year period. RSUs convert into common stock on the grant date on a one-for-one basis. On 8/8/16 25% of the shares were vested and released. A portion of the shares were held back to cover the statutory tax withholding requirement and the net shares were deposited into the holders account.

(2) Each Restricted Stock Unit, granted pursuant to the 2010 Employee Stock Option Plan, represents a contingent right to receive one share of Intuitive Surgical common stock. The grant vests 25% on the first anniversary of the date of grant and annually thereafter, over a four year period of time.
