(SSF3) and general partner of Special Situations Fund III QP, L.P. (SSFQP). Marx and Greenhouse are also members of SST Advisers, L.L.C. (SSTA), the general partner of Special Situations Technology Fund, L.P. (Technology) and the Special Situations Technology Fund II, L.P. (Tech II). AWM serves as the investment adviser to SSFQP, Technology, and Tech II. (SSF3, SSFQP, Cayman, Technology, and Tech II will hereafter be referred to
