- (1) Each restricted stock unit ("RSU") represents the right to receive, following vesting, one share of InfoSpace, Inc. common stock.
- (2) The original RSU grant was for 3,019 shares with the following vesting schedule: 16.7% of the RSUs shall vest on March 11, 2008 and the remaining RSUs shall vest ratably each six (6) months thereafter such that the RSUs shall be fully vested on September 11, 2010.
- (3) The original RSU grant was for 11,908 shares with the following vesting schedule: 33.3% of the RSUs shall vest on July 10, 2008 and an additional 16.7% shall vest each six (6) months thereafter such that the RSUs shall be fully vested on July 10, 2010.
- (4) These RSUs vest on December 20, 2008.
