Ownership includes this award of 127,983 restricted stock units. 76,790 units are performance stock units. The number of performance stock units vesting at the end of the three year period is predicated on meeting three-year performance conditions. The remaining 51,193 units will vest in three annual installments on the anniversary of the grant date. In addition, ownership includes previous awards of 555,000 restricted stock units subject to vesting requirements.
