- (1) The new grant is for 4,291 shares of common stock represented by time-based restricted stock units. The restrictions will lapse on 1,416 units on each of 2/21/12 and 2/21/13 and on 1,459 units on 2/21/14, subject to continued employment by the Reporting Person on the vesting dates.
- (2) The new grant is for 17,165 shares of common stock represented by performance-based restricted stock units, which may be adjusted up or down at the time the performance restriction lapses. The restriction may lapse with respect to 33% of such shares on each of 2/21/12 and 2/21/13 and with respect to 34% of such shares on 2/21/14 contingent on meeting an EBT metric for 2011 and subject to continued employment by the Reporting Person on the vesting dates.
- (3) The total number of securities beneficially owned includes: (a) 68,366 unrestricted shares; (b) 11,968 unvested units from an award of 35,200 performance-based restricted stock units granted 2/23/09; (c) 3,959 unvested units from an award of 5,908 time-based restricted stock units granted 2/22/10; (d) 16,857 unvested units from an award of 25,285 performance-based restricted stock units granted 2/22/10; (e) the new grant for 4,291 time-based restricted stock units; and (f) the new grant for 17,165 performance-based restricted stock units.
