MTS Announces Subscriber Growth Numbers for March 2009

Moscow, Russian Federation Mobile TeleSystems OJSC (MTS NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached **92.19** million users on **March 31, 2009**.

During March, MTS consolidated subscriber base increased by 0.4 million subscribers with 280 thousand subscribers added in Russia.
