On October 2, 2011, the Board of Directors of Regis Corporation (the Company) appointed Randy L. Pearce as Chief Executive Officer effective February 9, 2012. Mr. Pearce currently serves as the Company s President, a position he has held since February 2, 2011, and thus will hold the title of President and Chief Executive Officer commencing February 9, 2012. Mr. Pearce served as Senior Executive Vice President of the Company from 2006 to 2011, as Executive Vice President from 1999 to 2006, as Chief Administrative Officer from 1999 to 2011 and as Chief Financial Officer from 1998 to 2011. Additionally, he was Senior Vice President, Finance from 1998 to 1999, Vice President of Finance from 1995 to 1997 and Vice President of Financial Reporting from 1991 to 1994. Mr. Pearce will hold his office until a successor has been duly elected, or until his prior resignation or removal.
