**Item 2.02 Results of Operations and Financial Condition.**

On May 6, 2014, Primoris Services Corporation, a Delaware corporation ( Primoris , the Company ) issued a press release announcing its financial performance for the first quarter ended March 31, 2014.

The annual meeting of the stockholders of Primoris, was held on May 2, 2014. The total number of shares of the Company s common stock issued, outstanding and entitled to vote at the meeting was 51,655,224 shares. Represented at the meeting either in person or by proxy were 46,243,259 shares, or 89.5% of shares entitled to vote. The results of the votes for the proposals were as follows:
