(1) Represents a quarterly grant of unrestricted shares of the Company's common stock as part of the Company's non-management director compensation.

In connection with Mr. Ghasemi's retirement, effective June 30, 2014, based upon the award agreement, Mr. Ghasemi is entitled to vest in only a pro-rated portion of market stock units previously granted in December 2011, December 2012 and December 2013 (based on the portion of the performance period for which he was employed by the Company), which market stock units had previously been reported

(2) by Mr. Ghasemi at target achievement. As a result, the balance of securities beneficially owned following the transaction reported herein has been reduced by 40,608 shares, which represents the portion of the awards (and related dividend equivalents) previously reported at target in which Mr. Ghasemi is no longer eligible to vest. The ultimate number of shares of common stock to be issued to Mr. Ghasemi in respect of these awards will depend on the achievement of the performance criteria set forth in such awards.
