On May 5, 2015, the Audit Committee of the Board of Directors (the Audit Committee) of Global Power Equipment Group Inc. (Global Power or the Company), in consultation with its outside advisors and management, concluded that the financial statements for the annual period ended December 31, 2014 should not be relied upon because of accounting errors affecting the fourth quarter of 2014 that were discovered during the first quarter 2015 financial review process. The Company intends to file restated financial information as soon as practicable. Until the Company has finalized its accounting for the 2014 full year, as well as completed and filed an amendment to the prior report to correct the errors discussed above, the Company will be unable to file its Quarterly Report on Form 10-Q for the quarter ended March 29, 2015.
