This Registration Statement on Form S-8 is being filed by Heritage Commerce Corp, a California corporation (the **Company** or the **Registrant**) to register an additional 1,250,000 shares of common stock, no par value (the **Common Stock**), that have become available for issuance pursuant to the Heritage Commerce Corp 2013 Equity Incentive Plan (the **2013 Plan**). These shares are securities of the same class as other securities for which an original registration statement on Form S-8 (File No. 333-189955) was filed with the Securities and Exchange Commission (the **Commission**) on July 15, 2013 (the **Prior Registration Statement**).
