- (1) The Google Stock Units ("GSUs") entitle the reporting person to receive one share of Google Inc.'s Class A Common Stock for each share underlying the GSU as the GSU vests. The GSUs vest as follows: 1/4th of the GSUs shall vest on the one-year grant date anniversary and 1/16th each quarter thereafter until the units are fully vested, subject to continued employment with Google on the

applicable vesting dates.

- (2) 2,860 GSUs were withheld from the holder when the March 1, 2008 vesting occurred and 715 GSUs were withheld from the holder when the June 2, 2008 vesting occurred for tax purposes.
- (3) Each share of Class A Common Stock issued upon conversion of one share of Class B Common Stock at election of reporting person.
- (4) 1/4th of the Options shall vest on the one-year grant date anniversary and 1/48th each month thereafter until the options are fully vested, subject to continued employment with Google on the applicable vesting dates.
