The reporting person and his spouse contributed 941,128 common shares of the issuer to a limited partnership ("LP") in exchange for partnership interests. The reporting person and his spouse then each contributed his or her respective limited partnership interest to a separate trust, in each case with the contributing person's spouse as trustee and their children as beneficiaries.
