- (1) On February 3, 2012, Mr. Lutz was granted 58,369 performance stock units ("PSUs") representing rights to receive shares of SLM Corporation (the "Company") common stock in the future. On April 21, 2014, the PSU award and related dividend equivalent rights were adjusted as a result of the spin-off of Navient Corporation by the Company to reflect 61,988 restricted stock units ("RSUs") outstanding. On March 2, 2015, 61,988 shares of such RSUs vested and were issued to Mr. Lutz, of which 30,871 shares were withheld by the Company to satisfy Mr. Lutz's tax withholding obligations.
