- On May 1, 2014, Mr. Thome was awarded 12,012 Restricted Stock Units ("RSUs") representing rights to receive shares of common stock of SLM Corporation (the "Company") to vest in one-third increments on May 1, 2015, 2016 and 2017. On May 1, 2016, 4,004 shares of such RSUs vested, of which 1,296 shares were withheld by the Company to satisfy Mr. Thome's tax withholding obligations.
