1. Represents the value of the Reporting Person's Company Stock Fund Account in the Company's 401(k) plan as of March 3, 2003, expressed as share equivalents. As of such date, approximately 98% of such fund was invested in Company Common Stock, and the remainder was invested in cash.
2. Represents shares of restricted stock granted to the Reporting Person on October 8, 1996 under the Issuer's Long Term Stock Incentive Plan that may vest over the next three years.
- 2A. On January 28, 2003, 1,670 shares previously reported as being held in the Reporting Person's account in the Company's Salary and Bonus Deferral Plan were distributed to the Reporting Person under the terms of such Plan and are now reported as held directly.
- 2B. On March 7, 2003, the Reporting Person vested in 3,833 shares under the Issuer's Executive Long Term Incentive Plan and were distributed to the Reporting person.
3. Represents the value of the Reporting Person's Company Stock Fund Account in the Company's Supplemental Savings and Investment Plan as of March 3, 2003, expressed as share equivalents. As of such date, approximately 97.8% of such fund was invested in Company Common Stock, and the remainder was invested in cash. Please note that share equivalent accounting affects the total in column 5. No shares were actually bought or sold during this

period.

4. Represents an option granted to the Reporting Person on May 18, 2001 under the Issuer's Omnibus Incentive Compensation Plan to purchase 18,000 shares of the Issuer's Common Stock at \$16.87 per share.
5. Represents an option granted to the Reporting Person on January 24, 2002 under the Issuer's Omnibus Incentive Compensation Plan to purchase 30,000 shares of the Issuer's common Stock at \$12.24 per share.
