This Schedule 13D ("Schedule") relates to the acquisition of common stock of the Issuer whose principal executive office is located at 300 State Street East, Suite 226, Oldsmar, Florida 34677.

Mr. Gallagher is Chief Executive Officer of the Issuer, whose principal place of business is located at 300 State Street East, Suite 226, Oldsmar, Florida 34677.

On January 10, 2008, Mr. Gallagher was issued 5,000,000 shares of common stock pursuant to a Stock Purchase Agreement between the Issuer and Mr. Gallagher for consideration of \$150,000. On January 10, 2008, 221 Fund, LLC was issued 5,000,000 shares of common stock pursuant to a Stock Purchase Agreement between the Issuer and 221 Fund, LLC for consideration of \$150,000.

### Item 4. Purpose of Transaction

In a series of private transactions, 221 Fund, LLC was issued 5,000,000 shares of common stock of the Issuer and Mr. Gallagher was issued 5,000,000 shares of common stock of the Issuer, whereby Mr. Gallagher obtained beneficial ownership of a controlling share of the Issuer's securities. Upon completion of the transactions, Mr. Gallagher was appointed to the position of Chief Executive Officer of the Issuer.

2. An extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the issuer or any of its subsidiaries;
