- (1) On June 24, 2011, Mr. Biddle purchased 19,500 shares of Common Stock at a price of \$17.05 per share. This figure includes 837,500 restricted shares of Common Stock issued pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan and also includes 18,400 shares of Common Stock that Mr. Biddle has owned for a number of years, but which were inadvertently not included on prior Forms 4.
- (3) Mr. Biddle is the direct beneficial owner of 2,026,845 shares of Common Stock, including the 837,500 restricted shares noted in Footnote 2. In addition, he is the indirect beneficial owner of 35,326 shares of Common Stock, of which 4,280 shares are owned by two Trusts Established Under the Urstadt Biddle Properties Inc. Excess Benefit and Deferred Compensation Plans of 2000 and 2005, 2,307 shares are owned by the Willing L. Biddle IRA for the benefit of Mr. Biddle, 5,163 shares are owned by the P.T. Biddle (Deceased) IRA for the benefit of Willing Biddle, 21,951 shares are owned beneficially and of record by Catherine U. Biddle, Mr. Biddle's wife, 555 shares are owned by the Catherine U. Biddle IRA for the benefit of Catherine U. Biddle, and 1,070 shares are owned by the Charles and Phoebe Biddle Trust UAD 12/20/93 for the benefit of the Issue of Willing L. Biddle (the "Biddle Trust"). Mr. Biddle and Charles J. Urstadt are the sole trustees of the Biddle Trust.
