Item 1. Security and Issuer

This Amendment No. 1 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated January 1, 2011 and filed with the SEC on January 11, 2011 (the "Original Schedule 13D"), for Bank of America Corporation ("BAC"), Banc of America, N.A. ("BANA") and Blue Ridge Investments, L.L.C. ("Blue Ridge") (collectively, the "Reporting Persons") with respect to the auction rate preferred shares ("ARPS") of Federated Premier Intermediate Municipal Income Fund (the "Issuer"). The Issuer's principal executive offices are located at 4000 Ericsson Drive, Warrendale, PA 15086-7561.

This Amendment is being filed as a result of the reorganization of the Issuer into Federated Premier Municipal Income Fund ("FMN") on November 17, 2017 (the "Reorganization") pursuant to which BANA and Blue Ridge exchanged their 140 and 405 ARPS, respectively, for an equal number of ARPS of FMN.

All series of ARPS issued by the Issuer that vote together as a single class are treated as one class.

Item 2. Identity and Background

Item 3. Source and Amount of Funds or Other Consideration

Item 3 of the Original Schedule 13D is hereby amended by adding the following paragraph at the end thereof:

"In connection with the reorganization of the Issuer into Federated Premier Municipal Income Fund ("FMN"), the Reporting Persons exchanged their auction rate preferred shares ("ARPS") for an equal number of ARPS of FMN. No funds of the Reporting Persons were used in connection with the exchange of the ARPS."

Item 4. Purpose of Transaction

Item 4 of the Original Schedule 13D is hereby amended by adding the following paragraph at the end thereof:

"In connection with the reorganization of the Issuer into FMN, the Reporting Persons exchanged their ARPS for an equal number of ARPS of FMN. As a result of the reorganization, the Reporting Persons no longer beneficially own any ARPS."
