On February 9, 2010, Spectrum Brands, Inc. (“Spectrum Brands”) issued an investor presentation relating to the Agreement and Plan of Merger, dated as of February 9, 2010, entered into by and between Spectrum Brands and Russell Hobbs, Inc.
