Item 1.01. Entry into a Material Definitive Agreement.

On February 17, 2012, Consolidated Communications Holdings, Inc. (the “Company”) entered into the First Amendment (the “Amendment”) to the Amended and Restated Credit Agreement, dated June 8, 2011 (the “Original Credit Agreement”), among the Company, as Parent Guarantor, Consolidated Communications, Inc., as Borrower, the lenders referred to therein, Wells Fargo Bank, National Association, as administrative agent, issuing bank and swingline lender, CoBank, ACB, as syndication agent, General Electric Capital Corporation, as documentation agent, The Royal Bank of Scotland PLC, as documentation agent, and Wells Fargo Securities, LLC, as sole lead arranger and sole bookrunner. The Company previously disclosed its agreement to acquire (the “Proposed Acquisition”) of all the outstanding shares of SureWest Communications (“SureWest”), as disclosed in the Company’s Current Report on Form 8-K filed February 6, 2012 and its Current Report on Form 8-K filed February 8, 2012. The Amendment provides the Company with the ability to escrow proceeds from a high-yield note offering prior to closing the Proposed Acquisition, and, until closing, excludes the debt from current leverage calculations. The Amendment also permits the Company additional flexibility for future high yield notes issuances with the same subsidiary guarantees as the Original Credit Agreement. All other terms, coverage, and leverage ratios in the Original Credit Agreement were unchanged.

The description set forth above does not purport to be complete and is qualified in its entirety by the Amendment filed herewith as Exhibit 10.1 and is incorporated into this report by reference.
