**Item 7.01. Regulation FD Disclosure**

On December 15, 2008, Casey's General Stores, Inc. (the "Company") reported November 2008 same-store sales results for stores open for one full year. Same store gasoline gallons sold increased 0.8% in November 2008 compared to November 2007. The gasoline margin was below the Company's fiscal 2009 goal of 10.8 cents per gallon. The average retail price of gasoline sold during November 2008 was \$1.86 per gallon. Same-store sales of grocery and other merchandise increased 5.9% and prepared food and fountain same-store sales increased 7.6% in November 2008 compared to November 2007.
