**Item 7.01. Regulation FD Disclosure**

On February 17, 2009, Casey's General Stores, Inc. (the "Company") reported January 2009 same-store sales results for stores open for one full year. Same store gasoline gallons sold decreased 0.2% in January 2009 compared to January 2008. The gasoline margin was above the Company's fiscal 2009 goal of 10.8 cents per gallon. The average retail price of gasoline sold during January 2009 was \$1.74 per gallon. Same-store sales of grocery and other merchandise increased 7.2% and prepared food and fountain same-store sales increased 8.6% in January 2009 compared to January 2008.
