- (1) Prior to July 15, 2008, 41,460 shares were held in a trust established by the reporting person's mother for which the reporting person was the trustee. Accordingly, the reporting person remained the beneficial owner of 20,730 of the shares, although they are now reported as being held in his revocable grantor trust.
