 2,343 shares were withheld by the issuer to satisfy income tax withholding requirements related to the lapsing of restrictions on 6,429 shares of restricted stock awarded to the reporting person on 9/18/2003 (Form 4 filed on 9/22/2003). Because the reporting person's restricted stock holdings have been included in the direct ownership of Common Stock disclosed by the reporting person, the reporting person's direct ownership of Common Stock has been reduced by 2,343 shares to reflect this tax withholding.
