Represents restricted share units ("RSUs") granted under the Apollo Global Management, LLC 2007 Omnibus Equity Incentive Plan. Each RSU represents the contingent right to receive, in accordance with the issuance schedule set forth in the applicable RSU award agreement, one Class A share for each vested RSU. Subject to accelerated vesting in certain circumstances, the RSUs vest in installments in accordance with the terms of the applicable RSU award agreement, provided the reporting person remains in service through the applicable vesting date.

Subject to accelerated vesting in certain circumstances, the share option vests and becomes exercisable with respect to 833,333 shares on December 31, 2011, and vests and becomes exercisable with respect to the balance of the grant in equal quarterly installments of 208,333 (or 208,334) Class A shares from March 31, 2012 through December 31, 2016; provided that the reporting person remains in continuous employment through each such vesting date.

The price set forth above is on a per share basis. The share option represents a right to receive 5,000,000 Class A shares, subject to the vesting schedule described above in note (2).
