- (1) Shares held following the reported transactions include 39,050 restricted stock units, which are subject to forfeiture until they vest. Award represents a total of 39,050 restricted stock units granted under the terms of the Issuer's 2005 Stock Plan. Under the terms of the restricted stock unit grant agreement, 1/4 of the total number of units shall vest on each anniversary of June 15, 2012. Each unit represents a contingent right to receive one share of the Issuer's Class A Common Stock upon vesting.
- (2) This option was granted for a total of 168,075 shares of Class A Common Stock. 1/4 of the total number of shares issuable under the option vests on the first anniversary of June 15, 2012, the vesting commencement date, and the balance of the shares in equal monthly installments over the next 36 months thereafter.
