Each restricted stock unit (RSU) represents the right to receive, following vesting, one Logitech share. The RSUs vest and convert into shares in three equal annual installments. The first installment vests on January 4, 2014, and the next two vest on January 4, 2015 and January 4, 2016.

- (2) The option will vest and become exercisable on January 4, 2015 or later if and only when the average closing price per share of the Company's shares on the NASDAQ Stock Market over a consecutive 90 day period meets or exceeds the following performance criteria at any point during the first four years after the date of grant: 25% vest at \$11.75, 25% vest at \$13.70, and 50% vest at \$15.66.
