These TBRISUs vest as follows: 40% on the third trading day following the annual earnings release date for the fiscal year ending
- (2) December 31, 2014; 30% on the third trading day following the annual earnings release date for each of the fiscal years ending December 31, 2015 and 2016, respectively. Each tranche is settled within 10 business days after vesting.
