(1) The shares were acquired under the Molina Healthcare, Inc. 2011 Employee Stock Purchase Plan.

(3) 7,759 shares vest on each of March 1, 2015 and March 1, 2016; 3,072 shares vest on each of March 1, 2017 and March 1, 2018; 1,350 shares vest on October 1, 2014; and 1,875 shares shall vest upon the Company achieving total revenue in any of the 2013, 2014, or 2015 fiscal years equal to or greater than \$12 billion. The remainder of the shares are vested.
