**Item 8.01 Other Events.**

On May 26, 2005, U.S. Bank National Association (the "Trustee"), at the request of SBA Communications Corporation ("SBA") and SBA Telecommunications, Inc. ("Telecommunications"), gave notice of an optional partial redemption to the holders of the outstanding 9% senior discount notes due 2011 (the "Notes") pursuant to Section 3.07(b) of the Indenture, dated as of December 19, 2003, among SBA, Telecommunications and the Trustee (the "Indenture"). The redemption date will be June 30, 2005. As of June 30, 2005, prior to the redemption, the accreted balance of the Notes will be \$317,179,858. In accordance with the notice of redemption, SBA and Telecommunications intend to redeem outstanding Notes with an accreted balance of \$68,883,462. In accordance with the terms of the Indenture, the redemption price will be 109.75% of the accreted value of the Notes on the redemption date plus accrued and unpaid additional interest thereon, if any, to the redemption date. SBA and Telecommunications will use the net proceeds from SBA's issuance on May 11, 2005 of 8.0 million shares of its Class A Common Stock to redeem the Notes.
