By letter dated November 14, 2007, the Company reported that on that date several holders of the Company s Convertible Notes exercised their conversion rights. Hence, the financial indebtedness of the Company shall be reduced in US\$ 1,301,158 and accordingly, a capital increase of 2,562,330 ordinary shares face value pesos 1 each has been made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.96928 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 315,477,338 to 318,039,668. As the exercise period for the Company s Convertible Notes has expired, as of this date the Company will proceed to pay the outstanding amount of US\$ 89,126.
