This Report of Foreign Private Issuer on Form 6-K is deemed filed for all purposes under the Securities Act of 1933, as amended, and the Securities Exchange Act of 1934, as amended, including by reference in the Registration Statement on Form F-3 (Registration No. 33-99550) and the Registration Statement on Form F-3 (Registration No. 333-9180).

Following the split of Korea Development Bank ( KDB ) into Korea Finance Corporation ( KoFC ) and KDB Financial Group pursuant to government policy, the entire 192,159,940 common shares, or 29.95%, in Korea Electric Power Corporation ( KEPCO ) held by KDB as of October 28, 2009, were transferred to KoFC, an entity that will remain under government control, as of October 28, 2009. The total number of common shares directly or indirectly held by the Korean government, which amounted to 327,680,693 shares, or 51.07% of KEPCO s outstanding common shares as of October 28, 2009, remains unchanged.
