(b) On April 12, 2011, J. Sanford Miller, a director of Vonage Holdings Corp. (the Company), notified the Company of his decision not to stand for re-election as a director of the Company at its 2011 annual meeting of stockholders due to other business commitments, including time demands associated with his venture capital firm. Mr. Miller has served on the Company's board of directors since 2004 and served as the Company's Lead Independent Director from May 2006 to February 2010. He is expected to continue to serve as a director of the Company until the Company's 2011 annual meeting of stockholders, currently scheduled for June 9, 2011. The Company thanks Mr. Miller for his many years of leadership on its board of directors and valuable contributions to the Company.
