#### Press Release on ADS split

The shareholders of the Bank have at the Annual General Meeting held on  $6^{th}$  July 2011 approved the sub-division of one equity share of the Bank having a nominal value of Rs.10/- each into 5 (Five) equity shares having a nominal value of Rs.2/- each. The sub-division of the equity shares is being effected to facilitate more liquidity of the stock in the stock markets and to make it affordable for the small investors to invest in the equity shares of the Bank. Necessary instructions are also being issued to JP Morgan Chase Bank, the Depository for the ADSs issued by the Bank to effect necessary changes/split in the ADSs so as to ensure that the ratio between the ADS and the underlying equity shares remain 1:3 as at present. This will also help align the price of the ADSs to that of the Bank s peers and make the ADSs more accessible to the investors. The ADSs of the Bank are listed on the New York Stock Exchange (NYSE).
