This Amendment No. 10 to the Tender Offer Statement on Schedule TO amends and supplements the Tender Offer Statement on Schedule TO filed with the Securities and Exchange Commission on May 10, 2012 (together with any amendments and supplements thereto, the Schedule TO) by GlaxoSmithKline plc (GSK), a public limited company organized under the laws of England and Wales, and H. Acquisition Corp. (the Purchaser), a Delaware corporation and a wholly-owned subsidiary of GSK. The Schedule TO relates to the offer by the Purchaser to purchase all outstanding shares of common stock, par value \$0.01 per share (together with the associated preferred share purchase rights, the Shares), of Human Genome Sciences, Inc., a Delaware corporation (HGS), at \$14.25 per Share, net to the seller in cash, without interest and less any required withholding taxes, upon the terms and subject to the conditions set forth in the Offer to Purchase, dated May 10, 2012, (as subsequently amended and supplemented from time to time, the Offer to Purchase), and in the related Letter of Transmittal (as subsequently amended and restated from time to time) (which, together with any amendments or supplements thereto, collectively constitute the Offer).

All capitalized terms used in this Amendment No. 10 and not otherwise defined have the respective meanings ascribed to them in the Schedule TO.

Item 11. Additional Information

The Offer Section 16 Legal Proceedings is amended by inserting after the last paragraph thereof the following:

With respect to the foregoing case, *David, et al. v. Human Genome Sciences, Inc., et al.*, C.A. No. 1:12-cv-00965, on July 24, 2012, the District Court heard oral arguments on plaintiffs motion for a temporary restraining order.

On July 24, 2012, Joan Litwin, a purported HGS stockholder, filed a putative class action complaint for injunctive and other relief against HGS, the members of the HGS Board, GSK and the Purchaser in the United States District Court for the District of Delaware, captioned *Litwin v. Human Genome Sciences, Inc., et al.*, C.A. No. 1:99-mc-09999. Plaintiff purports to bring this action as a class action on behalf of herself and all similarly situated HGS stockholders. The complaint alleges, among other things, that the members of the HGS Board breached their fiduciary duties to HGS stockholders by approving GSK s \$14.25 per Share Offer and entering into the Merger Agreement,

and that HGS, GSK and the Purchaser aided and abetted in such breaches of fiduciary duties. The complaint seeks, among other things, an order enjoining defendants from consummating GSK s \$14.25 per Share Offer, compensatory damages, and an award of attorneys fees and costs. Both GSK and HGS believe that the lawsuit is without merit and intend to defend the action vigorously.

On July 24, 2012, David Markovic, a purported HGS stockholder, filed a putative class action complaint for injunctive and other relief against HGS, the members of the HGS Board, GSK and the Purchaser in the Circuit Court for Montgomery County, Maryland, captioned *Markovic v. Human Genome Sciences, Inc., et al.*, Docket No. 366054-V. Plaintiff purports to bring this action as a class action on behalf of himself and all similarly situated HGS stockholders. The complaint alleges, among other things, that the members of the HGS Board breached their fiduciary duties to HGS stockholders by approving GSK s \$14.25 per Share Offer and entering into the Merger Agreement, and that GSK and the Purchaser aided and abetted in such breaches of fiduciary duties. The complaint seeks, among other things, an order enjoining defendants from consummating GSK s \$14.25 per Share Offer, damages, and an award of attorneys fees and costs. Both GSK and HGS believe that the lawsuit is without merit and intend to defend the action vigorously.
