On February 10, 2014, David Friend, Chairman, President and Chief Executive Officer of Carbonite, Inc. (the Company) informed the Company s Board of Directors that he would resign as President and Chief Executive Officer of the Company effective upon his successor being named. Effective upon such resignation, Mr. Friend will become Executive Chairman of the Board of Directors and will continue to advise the Company on key strategic initiatives.
