**Panasonic Announces Dividends Forecasts**

Osaka, Japan, August 28, 2015 Panasonic Corporation ([TSE:6752] Panasonic ) today announced that its Board of Directors has resolved the forecast of interim dividends for the fiscal year ending March 31, 2016 (fiscal 2016). The record date for the interim dividend is September 30, 2015. The forecasts are as follows.
