- The Issuer withheld 214 shares of TCBI common stock to pay the taxes incident to Mr. Cargill's acquisition of TCBI common stock from
- (1) the vesting of the restricted stock units previously granted. As a result, Mr. Cargill acquired 593 shares of common stock (net of 214 shares of common stock withheld to pay related taxes).
 - (2) The restricted stock units were received by Mr. Cargill as an award grant under the Company's 2005 Long-Term Incentive Plan. Each restricted stock unit represents a contingent right to receive one share of TCBI common stock.
 - (3) The restricted stock units vest in five equal annual installments beginning April 24, 2007. Vested shares will be delivered to the reporting person within 2 1/2 months following the close of the calendar year in which the restricted stock units vested.
