(1) On December 9, 2008, December 10, 2008 and December 11, 2008, in accordance with a 10b5-1 Trading Plan, Morgan Stanley & Co., Incorporated, a registered broker-dealer, sold on behalf of Mr. Robert O. Carr, 26,500, 37,200 and 16,300 shares, respectively, of the Common Stock of Heartland Payment Systems, Inc. (the "Company").

(2) This price is the weighted average price of the 25,300 shares sold. The prices actually paid for the shares of the Company's Common Stock sold ranged from \$16.21 to \$17.20. The reporting person will provide to the issuer, any security holder of the issuer or the SEC Staff, upon request, information regarding the number of shares sold at each price within the range of prices actually paid.

(3) This Form 4 is filed in connection with a joint/group filing consisting of Mr. Carr and Jill Carr, Mr. Carr's wife. Mrs. Carr's address is c/o Heartland Payment Systems, Inc., 90 Nassau Street, Princeton, NJ 08542.

(4) This price is the weighted average price of the 1,200 shares sold. The prices actually paid for the shares of the Company's Common Stock sold ranged from \$17.21 to \$17.28. The reporting person will provide to the issuer, any security holder of the issuer or the SEC Staff, upon request, information regarding the number of shares sold at each price within the range of prices actually paid.

(5) This price is the weighted average price of the 28,200 shares sold. The prices actually paid for the shares of the Company's Common Stock sold ranged from \$16.41 to \$17.40. The reporting person will provide to the issuer, any security holder of the issuer or the SEC Staff, upon request, information regarding the number of shares sold at each price within the range of prices actually paid.

(6) This price is the weighted average price of the 9,000 shares sold. The prices actually paid for the shares of the Company's Common Stock sold ranged from \$17.41 to \$17.68. The reporting person will provide to the issuer, any security holder of the issuer or the SEC Staff, upon request, information regarding the number of shares sold at each price within the range of prices actually paid.

(7) This price is the weighted average price of the 16,300 shares sold. The prices actually paid for the shares of the Company's Common Stock sold ranged from \$16.56 to \$17.34. The reporting person will provide to the issuer, any security holder of the issuer or the SEC Staff, upon request, information regarding the number of shares sold at each price within the range of prices actually paid.

(8) After the sales, Mr. and Mrs. Carr beneficially own 5,095,399 shares of the Company's Common Stock and have a fully vested option to purchase an additional 125,000 shares of the Company's Common Stock.

(9) Mr. and Mrs. Carr's indirect beneficial ownership consists of 400,000 shares of Common Stock of the Company held by The Robert O. Carr 2001 Charitable Remainder Unitrust and 443,501 shares held by The Robert O. Carr 2000 Irrevocable Trust for Emily Carr. The reporting persons disclaim beneficial ownership of these securities, and this report shall not be deemed an admission that the reporting persons are the beneficial owner of the securities for purposes of Section 16 or for any other purpose.

(10) The reporting person no longer has a reportable beneficial interest in the 400,989 shares held by The Robert O. Carr 2000 Irrevocable Trust for Kelly Carr. included in the reporting person's prior ownership reports.
