(1) The option vests and becomes exercisable on a monthly basis, beginning as of July 1, 2009 (the "Vesting Start Date"), as to 9.09% of the underlying shares on the one-month anniversary of the Vesting Start Date and an additional 9.09% of the shares on each monthly anniversary thereafter, for as long as Mr. Skaff serves as a co-chairman of Glu's board of directors, such that the option will fully vest in 11 months at or around the date of Glu's 2010 Annual Meeting of Stockholders.
