- On October 5, 2009, 45,000 shares of Common Stock issued to the reporting person as Performance Earned Restricted Stock pursuant to the RPM International Inc. 2004 Omnibus Equity and Incentive Plan (the "Plan") vested. In accordance with the Plan, the reporting person disposed of 16,126 shares of Common Stock back to the Issuer to satisfy tax obligations of the reporting person.
- (1) Includes an aggregate of 53,661 shares of Common Stock issued pursuant to the 1997 RPM International Inc. Restricted Stock Plan, as amended, 96,393 shares of Common Stock issued pursuant to the 2007 RPM International Inc.
