- (1) This represents vesting of restricted stock units granted to Mr. Scodari on March 12, 2009. Upon each vesting date, each vested restricted stock unit automatically converts into one (1) share of common stock of Endo Pharmaceuticals Holdings Inc.  

This number represents (i) 8,970 restricted stock units (including the 2,834 restricted stock units reported in Table II), 3,068 of which are
- (2) fully vested and (ii) 4,611 shares of common stock. Mr. Scodari's beneficial ownership disclosed in this table excludes all shares held by Mr. Scodari indirectly, including shares underlying stock options.
- (3) Upon each vesting date, each vested restricted stock unit automatically converts into one (1) share of common stock of Endo Pharmaceuticals Holdings Inc.  

Fifty percent (50%) of Mr. Scodari's March 12, 2009 grant of restricted stock units (RSUs) generally vest on each of March 12, 2010 and
