- The shares represent restricted stock units that were received as an award, for no consideration. The restricted stock unit shall vest as to
- (1) 25% of the shares on September 19, 2012 and 12.5% of the shares every six months thereafter, such that the shares are fully vested on approximately the four (4) year anniversary of the date of grant.
  - (2) Includes 104 shares purchased pursuant to the Issuer's Employee Stock Purchase Plan on August 31, 2011 and 15,053 shares issued upon the vesting of restricted stock units previously reported on a Form 4.
  - (3) The shares are held by the Shannon Revocable Trust, dated 9/24/1997, of which the Reporting Person is co-trustee.
  - (4) The option shall vest as to 25% of the shares on September 21, 2012 and 6.25% of the shares at the end of each quarterly period thereafter, such that the option is fully vested on the four (4) year anniversary of the date of grant.
