Represents Restricted Stock Units ("RSUs") awarded under the Winn-Dixie Stores, Inc. Fiscal 2010 Equity Incentive Plan that were subject to achievement of certain financial performance criteria. The aggregate performance RSU's were originally awarded on November (1) 4, 2009 with 1/3 of the aggregate award being subject to performance criteria beginning on November 4, 2010. The second year performance criteria were determined to have been met on November 4, 2011 and the RSU's vested as to 1/3 of the original award. Each RSU represents a right to receive one share of Winn-Dixie Stores, Inc. common stock.  
(2) The amount of securities owned balance includes 6,742 RSUs for which stock certificates will be issued upon vesting.
