This total includes the 01/22/2015 grant of 11,031.404 restricted stock units and the 01/21/2016 grant of 9,694.525 restricted stock units, plus in each case, the incremental addition of restricted stock units credited to the original grant in amounts equal to dividend equivalents deemed earned on shares underlying such restricted stock units, and the 01/26/2017 grant of 4,133 restricted stock units.
