- As permitted under the Comtech Telecommunications Corp. 2000 Stock Incentive Plan, as amended, restricted stock units are awarded to the reporting person pursuant to his election to receive the value of the annual stock option grant he otherwise would have received in restricted stock units. Each restricted stock unit represents the right to receive one share of common stock of Comtech Telecommunications Corp. upon vesting of the unit.
- (1) Generally, the restricted stock units will vest in installments over a three year period, at a rate of 25% on the first and second anniversaries of grant and 50% on the third anniversary of the date of grant, assuming continued service as a director.
