(1) On September 30, 2014 the Issuer entered into a Debt Conversion Agreement with Mr. Howlett totaling \$36,150.30. Under the terms of the Debt Conversion Agreement, Mr. Howlett has the right to convert the debt amount into common stock of the Issuer as well as a warrant agreement to purchase one share for every two shares acquired. The expiration date on the warrant is 3 years from the date of conversion.

(2) On December 7, 2009, Mr. Howlett was granted an option to purchase shares of common stock under the Issuers Stock Option Plan dated July 17, 2006. On October 17, 2014 Issuer's board of directors approved to modify the options granted with a new expiry date of December 7, 2019.
