## **Clarifications on BMS-9 expected oil volumes**

(Rio de Janeiro, February 12, 2008). PETRÓLEO BRASILEIRO S/A - PETROBRAS, [Bovespa: PETR3/PETR4, NYSE: PBR/PBRA, Latibex: XPBR/XPBRA, BCBA: APBR/APBRA], a Brazilian international energy company, in reply to news about expected recoverable oil volumes in the BMS-9 block, which consortium is formed by Petrobras (45% stake), BG (30% stake) and Repsol (25% stake) wishes to clarify that up to now there isn't enough data to conclude about the recoverable oil potential. An assessment of the block oil volumes potential will be only possible with the continuity of the evaluation program.

Petrobras reaffirms that have only disclosed expected volumes for Tuoi discovery (5 to 8 billion boe) and Iara discovery (3 to 4 boe), both in the BMS-11 block.
